Sponsor reserves the right at its sole discretion to disqualify any individual it finds to be attempting to tamper with or undermine the entry process, the web site, and/or the legitimate operation of the Promotion; to violate the Official Rules; or to act in unsportsmanlike or disruptive manner or with the intent to annoy, abuse, threaten, or harass another person. Neither Sponsor nor their agents will be responsible for (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Promotion; (2) technical failures of any kind, including but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Promotion; (4) technical or human error which may occur in the administration of the Promotion or the processing of entries; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Promotion or receipt or use or misuse of any Prize. If for any reason the Promotion is not capable of running as planned including due to infection by computer virus or bugs, tampering, unauthorized intervention, fraud, technical failures, force majeure, or any other causes beyond the reasonable control of Sponsor, which correct or affect he operation, administration, security, fairness, integrity, or proper conduct of this Promotion, Sponsor may, in its sole discretion, void any suspect entries and (a) cancel or terminate the Promotion (or any portion thereof); (b) modify the Promotion or suspend the Promotion to address the impairment and then resume the Promotion in a manner that best confirms to the spirit of these Official Rules; or (c) award the Prize at random from the eligible, non-suspect entries received up to the time of impairment.
